Her Majesty is notified, and it is for her to notify Her Government that the people do have rights under our written constitution and that includes the right to petition The Queen. One unlawful arrest has been made in contravention of these rights and the shameful detention and handcuffing of a Subject in Wales, the subject offered no violence and was detained at a police station and handcuffs applied and kept on (no unusual or cruel punishment's).

The declaration of rights (the settlement terms agreed upon) held in its original form, at the chancery office House of Lords, is an original and true contract with the people. We as white pen dragon's public interest group and constitutionalists support Her Majesty and The Rule of Law via The Independent Judiciary\*.

This original contract is not being honoured by Her Majesties Parliament, which in our view Parliament is now tyrannous. Parliament is not sovereign, we are.

There is misfeasance in public office, The ECA 1972 should be made void (CO/4310/2017, High Court Case) as her Majesty and malfeasant advisors misled the people, the case should be heard.

The declaration of rights is a contractual document sworn by ceremonial oath; it is illegal under this lawful and valid contract to use the police or army against the people. (as seen recently in Spain).

“And they do claim, demand, and insist upon all and singular the premises as their undoubted rights and liberties, and that no declarations, judgements, doings, or proceedings to the prejudice of the people in any of **the premises ought in any wise to be drawn hereafter into consequence or example; to which demand of their rights they are particularly encouraged by declaration** of his highness the Prince of Orange as being the only means for obtaining a full redress and remedy therein. Having therefore an entire

confidence that his said Highness the Prince of Orange will perfect the deliverance so far advanced by him, and will still preserve them from the violation of their rights which they have asserted, and from all other attempts upon their religion, rights, and liberties”

Prince Orange reply:

15/02/1688 as recorded and appended to the declaration held in the chancery office. “My Lords and Gentlemen, This is certainly the greatest proof of **TRUST** that you have in us that can be given which is the thing that maketh us value it the more and we thankfully accept what you have offered and as I had no other intention of coming hither than to preserve your Religion, Laws, and Liberties so you may be sure that I will endeavour to support them and shall be willing to concur in anything that shall be for the good of the Kingdom and to do all that is in my power to advance the welfare and glory of the nation”

His Highness the Prince of Orange declaration 10/10/1688 first stated that the laws liberties and customs were being openly transgressed and annulled and that it was a wilful dereliction depriving subjects of their religion and their civil rights. These derelictions had come about because of “evil counsellors” (malfeasant advisors)

Prince of Orange stated “under great and just fears as they no longer have the right to petition or representation as authorised by law”

We simply assert our claim of right and right of claim under OUR constitution. Her Majesties Parliament is full of tyrants and the principle of parliamentary sovereignty is one of bad faith, which has never been put before a court. Our current Judges are now appointed\* by that same bad faith parliament.

We bear no malice towards Her Majesty or Her Heirs we simply want a fair hearing.
